



# Quicken for Mac Conversion Instructions

---

*Direct Connect to Web Connect*

## Introduction

As **State Bank of Southern Utah** completes its Online Banking conversion, you will need to modify your Quicken settings to ensure the smooth transition of your data. Please reference the dates next to each task as this information is time sensitive.

To complete these instructions, you will need your login credentials for Direct Connect and/or online banking.

**NOTE:** **Direct Connect** may require registration. Please contact **State Bank of Southern Utah** to verify your Direct Connect login information. **Web Connect** uses the same User ID and Password as the bank's online banking website.

You should perform the following instructions exactly as described and in the order presented. If you do not, your online banking connectivity may stop functioning properly. This conversion should take 15–30 minutes.

## Documentation and Procedures

---

### Task 1: Conversion Preparation

---

1. Backup your data file. For instructions to back up your data file, choose **Help** menu > **Search**. Search for **Backing Up**, select **Backing up data files**, and follow the instructions.
2. Download the latest Quicken Update. For instructions to download an update, choose **Help** menu > **Search**. Search for **Updates**, select "Check for Updates," and follow the instructions.

### Task 2: *Optional task* - Complete a final download **before June 20, 2020**

---

1. Select your account under the **Accounts** list on the left side.
2. Choose **Accounts** menu > **Update Selected Online Account**.
3. Repeat this step for each account (such as checking, savings, credit cards, and brokerage) that you use for online banking or investing.

---

**Task 3:** Disconnect Accounts in Quicken on or after **June 20, 2020**

---

1. Select your account under the **Accounts** list on the left side.
2. Choose **Accounts** menu > **Settings**.
3. Select **Troubleshooting** > **Deactivate Downloads**.
4. Repeat steps for each account to be disconnected.

---

**Task 4:** Reconnect Accounts to **State Bank of Southern Utah WC New** on or after **June 23, 2020**

---

5. Select your account under the **Accounts** list on the left side.
6. Choose **Accounts** menu > **Settings**.
7. Select Set up transaction download.
8. Enter **State Bank of Southern Utah WC New** in the **Search** field, select the name in the **Results** list and click **Continue**.
9. Log in to [www.sbsu.com](http://www.sbsu.com). **Download** a file of your transactions to your computer.

**NOTE:** Take note of the date you last had a successful connection. If you have overlapping dates in the web-connect process, you may end up with duplicate transactions.

10. Drag and drop the downloaded file into the box **Drop download file**.

**NOTE:** Select "Web Connect" for the "Connection Type" if prompted.

11. In the "**Accounts Found**" screen, ensure you associate each new account to the appropriate account already listed in Quicken. Under the **Action** column, select "**Link**" to pick your existing account.

**IMPORTANT:** Do **NOT** select "**ADD**" under the action column unless you intend to add a new account to Quicken.

12. Click **Finish**.
13. Repeat steps for each account to be reconnected.
